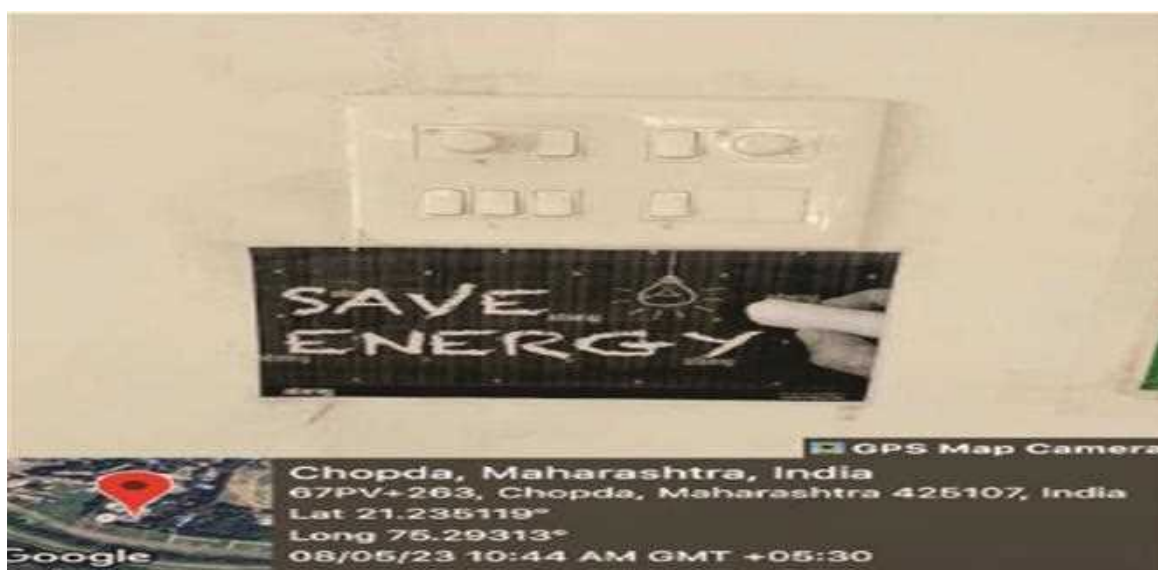

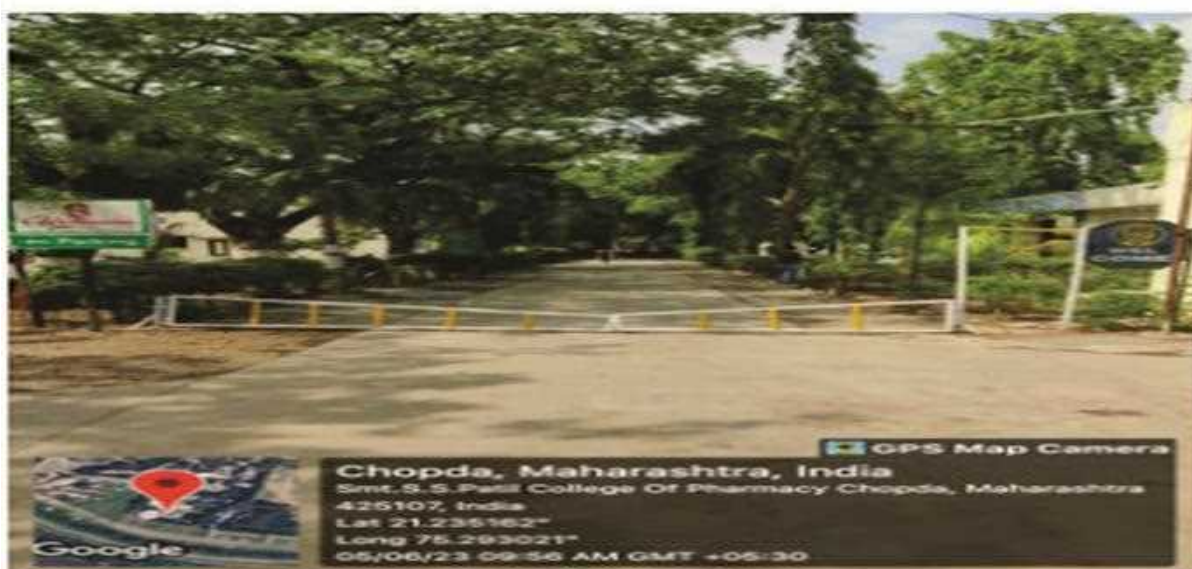

The institute promotes the concept of three R's - "Reduce, Reuse and Recycle" motto to dispose the waste as much as possible while ensuring its proper disposal thus making for a clean and healthy campus. The institution has taken several initiatives for solid waste management, liquid waste management, and biomedical waste management, e-waste management including the waste recycling and hazardous chemicals and radioactive waste management. Ecological, economic and social framework is preserved and protected. The institution has decided to have a long-term commitment towards the established policies, to take a shared responsibility for the future. Blue, green red and yellow coloured dust bins are placed wherever necessary.

Solid Waste Management

Littering of waste prohibited on the campus. Separate dustbins for biodegradable and non-biodegradable wastes, placed at various locations on campus including class rooms, laboratories, administrative office etc., The dustbins are labelled with instructions to distinguish the waste.

Larger quantities of biodegradable waste were destroyed through incinerator to make environment free from pathogens. Yard waste is collected, dried up and used as compost for the college garden.

Liquid Waste Management

Waste water and other neutralised liquid waste from the laboratories are disposed through well-constructed drainage system, which collects in to the separate soaking pits available at individual blocks. Waste water from RO plant is de-scaled and is used for watering the plants and flushing the toilets.

7.1.2 The Institution has facilities for alternate sources of energy and energy Conservation Measures :

The Institution is conscious about electricity conservation right from the beginning' All the buildings are constructed to provide ample natural light during the day time' this saves considerable amount of electricity. Earlier tube lights were used in the laboratories and staff rooms. These have been replaced as and when the need arose by LED lights thereby reducing the consumption of electricity by almost 40percent. These measures have been practiced since last years.

The electricity bills are collected annually and audited by an authentic agency to monitor the consumption of electricity and develop measures to save the consumption from time to time' sensor based lights will be installed in the office shortly as a measure to be taken to save more electricity. Save electricity posters are placed in every laboratory and in the campus.

In microbiology and other subject practical's the autoclave has to run almost daily for practical and project work for sterilization of media Also the hot air oven is used for sterilization of glassware' The department has made it mandatory to use the equipment in such a way that all the sterilization work of the entire classes is done, simultaneously only once a day. This prevents the recurring use of the equipment and there by saves electricity 'All the heavy duty instruments are put off when they are in out fuse state. Strict monitoring of switching off the lights and fans. As well as of other appliances is done in the campus and vigilance of the same is maintained before leaving the laboratories, classrooms and staff rooms in the campus.'

The green practices adopted by the institution are discussed here under 'Rain water recycling and harvest rain water to resolve and manage water scarcity problems that may arise in the future. our maintenance staff regularly, inspects tap leakages and attends to repair needs immediately to avoid loss of potable water' The use of water is minimized in hostels by facilitating the use of washing machines

Water Resources and Rain Water Harvesting. As the college is located in a hot climatic zone. the college realizes the importance of conservation and the best utilization of ,water resources. The college maintains and generates water resources. The college has a bore well to meet the general needs of the institution. The institution encourages recycling of Ro water and rain water harvesting. The water from the roof tops along with the rain water is collected through a well-connected pipe work delivery system. This arrangement is helpful in collecting water. Which is then collected into pits' specially constructed for this purpose. The rain water stored in the pits" issued for the maintenance of the green cover on the campus. In the hot summer season, when water scarcity is more, the surrounding bore wells get recharged and the ground water level increases Energy Consumption LED bulbs are used in maximum to save energy. Electric and electronic equipment is turned off when not in use.
