PHARMA UPDATES

Nipah Virus Infection

Nipah Virus Infection (NiV) is an emerging infectious disease of public health importance in the South-East Asia Region.

NIPAH OUTBREAKS

Nipah virus infection has proven to be fatal in 70 per cent of the cases. Since the first outbreak which happened in 1998 in Malaysia, the incidents of outbreak have occurred almost every year in Bangladesh and twice in West

The virus

The virus is named after the Malaysian village where it was first discovered. This virus along with Hendra virus comprises a new genus designated Henipavirus in the subfamily *Paramyxovirinae*.

Reservoir of virus

Fruit bats of the genus *Pteropus* have been identified as natural reservoirs of NiV. A seroepidemiologic study in Malaysia implicated four fruit bat species, *Pteropus hypomelanus*, *P. vampyrus*, *Cynopterus brachyotis*, *Eonycteris spelaea*, and an insectivorous bat, *Scotophilus kuhlii*.3 Nipah virus has been isolated from the brain and spinal fluid of victims in Malaysia.4 Infective virus has also been isolated from environmental samples of bat urine and partially-eaten fruit in Malaysia.5

The mode of transmission

Infected bats shed virus in their excretion and secretion such as saliva, urine, semen and excreta but they are symptomless carriers. The NiV is highly contagious among pigs, spread by coughing. Direct contact with infected pigs was identified as the predominant mode of transmission in humans when it was first recognized in a large outbreak in Malaysia in 1999. Ninety percent of the infected people in the 1998-1999 outbreaks were pig farmers or had contact with pigs.

Magnetic Bacteria- as Nanorobotics

Researchers at the Polytechnique Montreal NanoRobotics Laboratory have found that a bacterium called waters with little oxygen, imbued with magnetic capabilities can be a way to deliver targeted loads of chemothera effects. The bacteria have adapted to the environment with magnetic nano crystals that act like a compass guiding them north, as well as oxygen sensors that lead them to the deeper waters. Axiostat: India's first USFDA- approved wound dressing product

It wants to focus on India and other emerging markets, while at some stage, perhaps sometime in 2019, it may also look at a for a Being touted as the first US Food and Drug Administration (USFDA) approved wound-care product from India, Axiostat stops uncontrolled bleeding from wounds. Easy to use, it is a handy pack of about 8X8 centimetres. The patch when applied on a wound reacts with blood and within a minute of application forms a clot and becomes an extremely sticky adhesive. Talking about the product, Leo Mavely, founder and CEO of Bengaluru-head quartered Axio Bio solutions, says, while the company was set up about a decade ago, it went commercial only in 2014. It got the approval from the US drug regulator in February this year. The company has so far supplied the product to the Indian army and some of the military and private (corporate) hospitals. "So far, we have shipped close to 450,000 units. About 18 months ago, we set up our own manufacturing unit (earlier used to outsource) in Ahmedabad with a capacity to make 850,000 units per annum and this we hope will handle demand for the next two

years," says Mavely. The technology, he says, has a patent in India and is one of the first product in the world to have 100 per cent active ingredient - Chitosan - sourced from shellfish. "It is a novel biomaterial and we source it from shellfish. It has no protein content so is fully biocompatible for use in human body," says Mavely. The product is made 100 per cent from the active ingredient - Chitosan - and that is its USP. The company has already raised a total of over Rs 60 crore from Ratan Tata's RNT Capital (early this year) and earlier from Accel Partners and IDG Ventures India. It wants to focus on India and other emerging markets, while at some stage, perhaps sometime in 2019, it may also look at a foray into the US market. It already has an office in Boston and is scouting for a partner in the US - could be a group purchasing organization or a large distributor that works with the public health system in the US. Axio Bio solutions has close to 100 employees, including those in the R&D, sales, production and quality into the US market.

Mushrooms of the Far East hold promise for the anti-cancer therapy03 may 2018

Mushrooms from the Far East area contain the natural chemical compounds, which could be used for the design of the novel drugs with highly specific anti-tumor activities and low-toxicity. These compounds may offer new avenues for oncology, providing us with either stand-alone alternatives to chemotherapy, chemo preventive medicines, or drugs to be used in combination with other therapies. It contains the list of tumors, which were reported to be promising targets of the fungal compounds. Among them sarcoma, leukemia, rectum and colon cancer, stomach cancer, liver cancer, colon carcinoma and others. For the purpose of the current study scientists chose mushrooms widely used in Asian and Far Eastern folk medicine: Fomitopsispinicola, Hericiumerinaceus, Inonotus obliquus, and Trametes versicolor. These species of fungi were shown to selectively target certain malignant tumors. The desired effect is achieved thanks to the various bioactive compounds contained in the mushrooms: polyphenols, polysaccharides, glucans, terpenoids, steroids, cerebrosides, and proteins. These substances are not only capable to hit different critical targets within cancer cells levels but also in certain cases to synergistically boost the chemo. Scientists emphasize that four species of fungi were chosen due to the fact that their medicinal properties are relatively well described. Some of them are already actively used for the anti-cancer drugs manufacturing in certain countries. Undoubtedly, there are many other species of fungi that contain chemical compounds to defeat cancer cells. In ancient China mushrooms were considered as the most effective treatment for the various types of tumors. Contemporary fungo therapy (treatment by means of mushrooms) represents a promising field for scientific research. The natural chemical compounds contained in fungi have a huge therapeutic and particularly the anti-cancer potential that has not been yet fully studied", says Professor Vladimir Katanaev, Dr. Habil, Ph.D., Head of the Laboratory of Pharmacology of Natural Compounds of the Department of Pharmacology and Pharmacy of the School of Biomedicine, FEFU. Another co-PI and corresponding author of this work, director of the center for genomic and regenerative medicine of the School of Biomedicine, FEFU, Alexander Kagansky, notes that despite that the interest in mushrooms studying has been growing exponentially over the past 60 years, about 90% of the fungal species have never been analyzed for their antibiotic and antitumor activities.
